The undersigned, being duly advised in the premises, and in consideration of provision of opportunity and limited license and authority to trespass on real property for the purpose of river cleanup in designated areas, does hereby specifically and completely release and forever discharge and hold harmless the Niobrara Council and any affected associated landowner from any and all actions, cause of action, claims, injuries, losses and demands for, upon or by reason of any damage, loss of injury in consequence of or as a result of said river cleanup as above set forth.

In support of said release, I acknowledge that I am well and personally familiar with the dangers and hazards associated with the Niobrara River and with unfamiliar lands, and that I am willing, able, and do voluntarily waive and release the Niobrara Council and individuals from any liability whatsoever at, participation in or us of the opportunity as above set forth this time, or at any time in the future until the end of the world. I furthermore agree to indemnify and hold harmless the Niobrara Council for any injuries, liabilities, damages or other claims or demands for myself, my agents, my personal representatives, assigns or relatives and family whatsoever, including costs of defense of any such claim which may be filed. I further certify that I have made my own independent evaluation of the dangers associated with said activities, and that I am personally familiar with the possible consequences of said activities and with the consequences of this release.

I do further bind myself, my heirs, administrators and personal representatives as equally as I do bind myself.
